4. **Projects (Discussed):**

- A. TMC will inspect driveways this week for the replacement program in the fall.

5. **The following Old Business was discussed:**

- A. The common area reserve study report was perused.
- B. Various pool signage and pool depth markers were discussed. In addition, TMC will have the pool company inspect the rust staining coming from the gutter system.
- C. The rubber flooring for the gym room was discussed; proposals are forthcoming.
- D. The DJ for the Labor Day community event was not utilized; therefore, \$350- was not spent.

6. **The following New Business was discussed:**

- A. The tennis court benches were installed.
- B. TMC will obtain a copy of the engineering report for the outdoor pool.
- C. A/C unit is leaking in the gym. TMC will have this issue inspected.
- D. TMC will again contact the town with regard to the damaged service walk at #50 Federal.
- E. The September and November Clubhouse rental dates were discussed.
- F. The #9 Appomattox walkway repair will be inspected; as there may be a tree on the homeowner's property that needs to be removed before the concrete repair could be made.
- G. The paver request at #5 Federal was discussed. The homeowner is only permitted to use pavers on the property they own.
- H. The feeding of deer is not permitted within the town of Brookhaven. TMC will send out letters to those on Gettysburg and Charleston informing them of this policy.
- I. **Motion #091112A**- Made by John Romashko, Jr., 2<sup>nd</sup> by Helene Singer, unanimously approved, to have Alex Concrete remove and replace walkway (48'x 6') and front slab (30'x 7') at the Clubhouse (including the ramp). In addition, (2) cement flags on the south side will be replaced for a total cost of \$5,525.00
