  - 2. Filter replacement cost: \$8,960 + tax for main pool. Motion Charlotte Romashko 2<sup>nd</sup> Charles Congema- unanimously.
  - 3. Seasonal contract \$37,000 + tax Motion Charlotte Romashko 2<sup>nd</sup> Phyllis Krilovich passed unanimously.
  - 4. Pool surface – diamond polish, as per proposal cost \$6,200 + tax. Motion Charlotte Romashko 2<sup>nd</sup> Helene Singer- passed unanimously.
  - 5. New depth markers- cost \$1,200 + tax. Motion John Romashko 2<sup>nd</sup> Phyllis Krilovich- passed unanimously.
