III. MANAGEMENT REPORT

- **A.** reviewed and accepted, including financials, notices before liens, modification requests, house rule violations and warnings, home sales, etc.
- **B.** Interviews of 3 candidates to fill the open board position are scheduled for tomorrow, 8/17/22. A final decision will be discussed and made at the September board meeting.

IV. REPORTS OF OFFICERS

- A. PRESIDENT creation of bocce court should be put on hold motion passed unanimously
- B. VICE PRESIDENT Trees belong to the Town when they are within 6 feet of the street; handicapped parking spot in Delaware Ct. has been eliminated since it is no longer necessary for any resident
- C. TREASURER over \$100,000 has been spent on concrete this year; money for clubhouse renovations has been accruing for many years; arrears have been slowly decreasing
- **D. SECRETARY** once a new board member is selected he/she will fulfill the rest of the unexpired term of Charles Congema, through 2025.

V. COMMITTEES

- **A. POOL** additional umbrellas and stands will be ordered and put in place for next pool season; pergola needs to be scraped and re-painted after this pool season ends
- **B. ARCHITECTURAL** many ongoing renovations are taking place; reminder to homeowners to fill out proper forms to make appropriate requests
- C. RECREATION no availability of barbecue food truck this late in the summer, but a date will be set early for big event next season
- VI. CLUBHOUSE RENTALS available, dependent on conformity with Suffolk County and Board of Health Covid-19 protocols.

- F. Trees Anderson will be removing the Canal Road trees at the end of September; they will be on site for other days of work as well, as the list generated from homeowner work requests is continually updated
