VII New Business-no increase of numbers on gas conversion; new signs at front entrance installed; Lawn Chemical proposal approved –no cost increase from last year-notice to be mailed to homeowners; Large amount of Storm Cleanup required-Motion to pay Anderson Tree Service for 2 full days as well as TMC for its crews for a Total expenditure not to exceed \$17,000 -- Passed unanimously; Format for Annual Meeting and its agenda discussed; Election Mailing #1 is in the mail, petitions and instructions for candidates available in the clubhouse; 2016 Hot Dog Picnic will be sponsored by The Management Co. since no money in SCHOA budget
